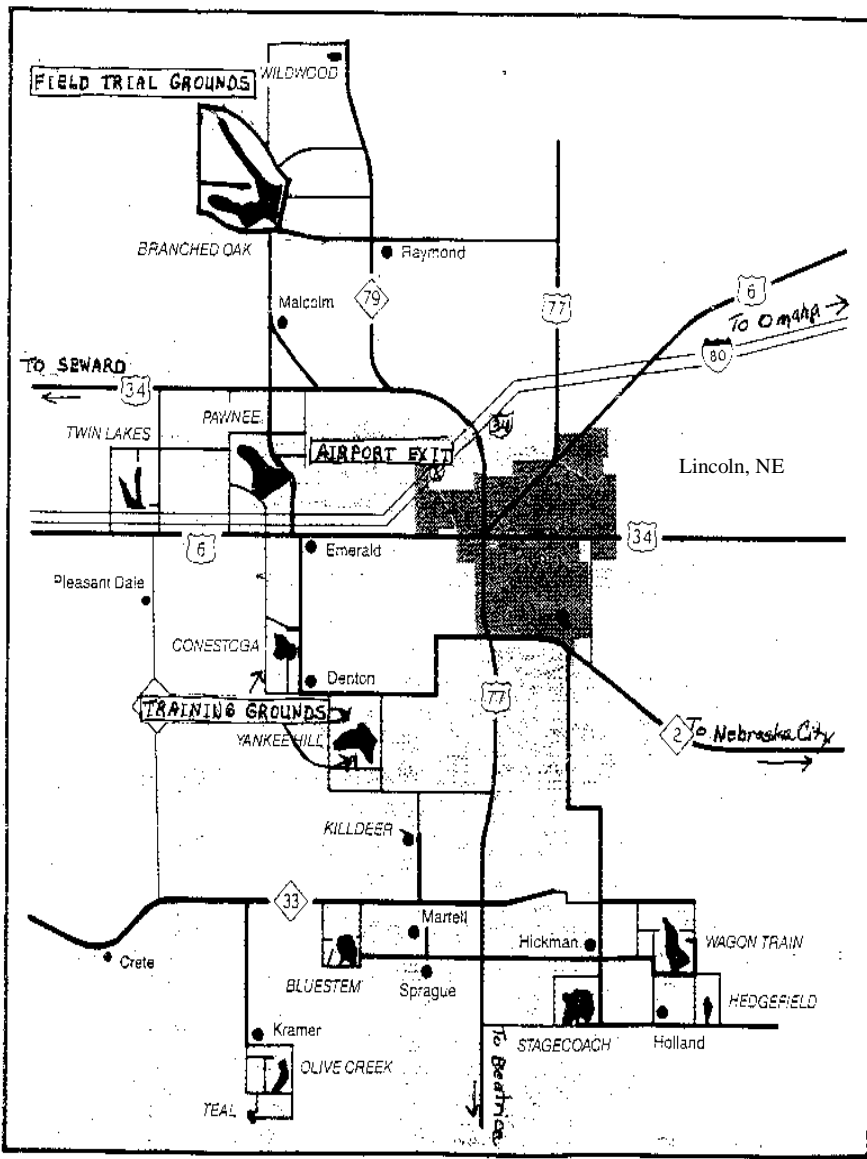


Branched Oak Dog Trial Area & Yankee Hill

The field trial grounds are located at the Northwest corner of the lake and the entrance is on the left, marked with a sign.

Attention: To all participants that have dogs / horses or both, you are responsible for cleaning up after your animals-REMOVE all horse and dog manure-because there are other people using the same area next week. Also please pick up all baling wire/twine so not to get caught in the mower.

Entries will be limited to Number of dogs, which can be run during daylight hours. Entries will close when the limit is reached if this occurs prior to specified closing time.

COURSES & BIRDS

Amateur Limited Gun Dog & Open Limited Gun Dog are **not** retrieving stakes.

All Stakes – Multiple courses without a bird field

Amateur Gun Dog and Open Gun Dog – Call back for retrieve
Quail and/or chukar/pheasant will be used in all stakes except Puppy.

A blank cartridge will not be fired in the Puppy Stakes.

Horseback handling will be permitted in all stakes

AKC Approved Tracking Collars permitted.

Camping: Overnight camping is allowed on the grounds. There is a \$3.00 charge per day for electrical hook-ups – payable to the Field Trial Chairman. Showers are located in nearby park facilities. State park stickers will be required to use park facilities outside of the field trial grounds.
