DIRECTIONS TO GROUNDS

Going west on I-80: Take the North 27th street exit, at the stop sign turn right, go 1/2 mile to Arbor Rd., turn left go 1 mile to North 14th, turn right on North 14th, go to yellow flashing light which is Raymond Rd., Turn left, stay on Raymond Rd. for 8 miles, there will be a curve in the road. If you turn right you will go to Branched Oak Trial Area.

Going east on I-80: From I-80 take the Seward/HWY 15 exit, which is North to Seward. At the stop light in Seward turn right which will be HWY 34, stay on this HWY for 12 miles you will see a sign that says Branched Oak. There is only one way to turn, which is north and puts you on NW 112th. It takes you through the town of Malcolm. Stay on this road for 5 miles and you are at the lake. If you turn left you will go to Branched Oak Trial Area
