Amateur Limited Gun Dog, single course without bird field, birds released on back course, blank gun used, **non retrieving**.

All stakes except Open Puppy: Pheasants and/or quail and/or chukars. **Horseback handling is permitted in all stakes.** Only blank guns or starter pistols incapable of firing live ammo are permitted.
